### ORDINANCE #11-26

# AN ORDINANCE FOR LICENSING OF LIMOUSINES WITHIN THE BOROUGH OF GLASSBORO

WHEREAS, the Borough of Glassboro recommends adoption of a new Chapter in the Code Book of the Borough of Glassboro entitled "Limousines" be established.

NOW, THEREFORE, BE IT ORDAINED by the Borough of Glassboro, County of Gloucester, and State of New Jersey as follows:

Section 1. The Borough of Glassboro does hereby adopt a new Chapter to read as follows:

#### Limousines.

From and after the effective date of this chapter, no person shall pick up for hire any person in any formal limousine in the Borough of Glassboro unless both the formal limousine and driver conform to all the provisions of N.J.S.A. 48:16 et seq.

Section 2. All prior Ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

Section 4. This Ordinance shall take effect immediately after final passage and publication as required by law.

# AN ORDINANCE AMENDING ORDINANCE #11-26 FOR THE LICENSING OF LIMOUSINES WITHIN THE BOROUGH OF GLASSBORO

WHEREAS, the Borough of Glassboro adopted Ordinance #11-26 for the licensing of limousines within the Borough of Glassboro; and

WHEREAS, annual fees for such licensing need to be established.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Glassboro that Ordinance #11-26 is hereby amended by creating a new section to read as follows:

Section 1. Annual Fees due on January 1<sup>st</sup> of each year for the period of January 1<sup>st</sup> to December 31<sup>st</sup>:

- Limousine/Taxicab Business –
  \$50.00 per vehicle;
- Limousine Drivers –
  \$10.00 per driver

### Section 2. Repealer

All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

## Section 3. Severability

Each section of this Ordinance is an independent section and the holding of any section or part thereof to be unconstitutional, void or ineffective,

shall not be deemed to affect the validity or constitutionality of any other sections or parts hereof.

Section 4. BE IT FURTHER ORDAINED that this Ordinance shall take effect immediately upon final passage and publication as required by law.
