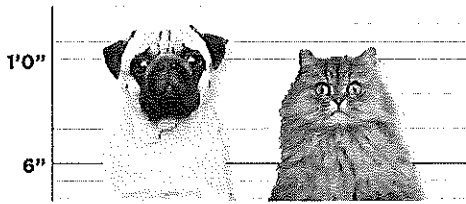

Pet Licenses

Dog and cat licenses can be purchased at Borough Hall or by mail. When mailing your payment, please provide current rabies information (valid through November 1st of the licensing year), and proof of spay/neuter, along with a self-addressed-stamped-envelope for return mail. Checks should be made payable to the Borough of Glassboro (separate checks for dogs and cats), 1 South Main Street, Glassboro, NJ 08028-2592.

The Code of the Borough of Glassboro, Chapter 156, limits the number of dogs and/or cats to 3 per property. Licenses are issued annually, beginning January 2nd for all dogs and cats. Any license issued April 1st or after is subject to a \$10.00 late fee.

State law requires that rabies vaccination must be current to November 1st of the licensing year. All pets must be licensed, including indoor dogs/cats. Residents are responsible for licensing/re-licensing their pets. The Borough does its best to remind its residents to renew their licenses, through information available on the Borough website, and advertisement in the local newspaper. Through these two venues you will also find information about our annual free rabies clinic.

For your convenience we now accept cash, check or credit card.

Pet License fees are as follows:

Spayed/Neutered Dogs and Cats	\$ 12.00 each
Non-Spayed/Non-Neutered Dogs and Cats	\$ 15.00 each

Early boosting has not been associated with an increased occurrence of adverse reactions and is not medically contraindicated.</p>

<p>By signing below, I acknowledge that I am the owner of the animal described above. I have been informed that this animal is exempt from rabies vaccination for a period of up to one year. I have also been informed of the following important information:</p> <ul style="list-style-type: none"> • This animal must be re-examined by the expiration date listed above. At that time the animal must either be vaccinated against rabies or, if exemption status still applies, a new certificate must be issued. • Once the duration of immunity from the last rabies vaccination has lapsed, this animal is not protected against rabies and, as a result, is at increased risk of becoming infected if exposed to a rabid animal. • It is recommended that the animal be closely observed when outside, walked on a leash and not allowed to run at large. Prevent the animal from coming into contact with suspect rabid animals such as raccoons, skunks, foxes, groundhogs, bats and free-roaming cats. • Exemption from rabies vaccination does not exempt the animal from other laws related to rabies. If this animal is potentially exposed to rabies (e.g., due to a bite or exposure from a rabid or suspect rabid animal), the local health agency will require it to be euthanized or quarantined for six months. If this animal potentially exposes a person to rabies (by bite or other means), it must be confined for 10 days as approved by the local health agency where the animal resides.

A copy of this certificate must be provided to the owner of the animal listed above and kept as proof of exemption. For dogs, this certificate must be presented with an application for a dog license.
